FARM LEASE, Cash Rent, Installments, Security Interest Clause

THIS AGREEMENT, Made this 15th day of April, 2015

 and State of Minnesota, party of the second part, Lessee.

WITNESSETH, That the said party of the first part, in consideration of the rents and covenants hereinafter mentioned, does hereby Demise, Lease and Let unto the said party of the second part, and the said party of the second part does hereby hire and take from the said party of the first part, the following described premises situated in the County of Houston, and State of Minnesota, viz:

in Section Number 1, Township Number 102N, Range Number R-6-W, containing 4 acres be the same more or less, of which described premises the second party hereby agrees to plow and put in crops not less than 4 acres each year during the continuance of this Lease.

To Have and to Hold, The above rented premises unto the said second party, heirs and assigns, subject to the conditions and limitations hereinafter mentioned for and during the full term of 4 years from and after the 1st day of April, 2015, the term of this Lease ending the 31st day of December, 2018.

And the said second party agrees to and with the said first party to pay as rent for the above mentioned premises, for and during the full term of this Lease, the sum of NINE HUNDRED DOLLARS (\$900.00) per year Dollars, payable at total of thirty-six hundred dollars / term of the lease in 4 installments with

interest at the rate of — per cent on each installment after due, to-wit:
